Australia's Significant Investor Visa

The Significant Investor Visa was introduced by the Australian Government in November, 2012.

Applicants for the visa must:

- submit an expression of interest in SkillSelect;
- be nominated by a State or Territory Government; and
- make investments of at least 5 million Australian dollars into complying investments.

These investments include:

- Federal, State and Territory Government bonds;
- managed funds regulated by the Australian Securities and Investments Commission; and
- direct investment into Australian proprietary companies.

There are no upper age limits for applicants and visa holders must spend at least 160 days over 4 years living in Australia.

Visa terms can be extended, subject to certain requirements.
